 - Pilot program started 7/27/21; Marin based team, training, 5 days, equipment; Kaiser agreed to 2 days pay for call time
 - Marin-based team of five nurses; nurses received SANE training; starting August 2021 nurses provided availability
 - Marin team; 3 RNs, 1CNM; exams started March 1, 2022 at Kaiser San Rafael ER
 - Pros: 70% increase in testing; 2 Marin based nurses; one male examiner
 - Challenges: more examiners needed; terrible hours as examiners are on call; low pay
 - Marin County program is set up as a nonprofit so not as restrictive but doesn't receive government funds
 - LF: move to make SART permanent and will be put in the budget request; it has been proven that it was needed. This is a good time to remind BOS and LF will. There will be a budget by the end of the month; LA: All commissioners have meetings with their supervisors and will remind them
 - LF: over ½ of victims are women of color; examiners must be very proficient to deal with children
 - KC: SANESAT was nominated for Hearts of Marin, KC for leadership
